### **DEFINITIONS**

## **EU PRODUCTION**

Actual production in the EU, excluding all imports from outside the EU and all purchases from other EU based producers, but including authorised production under rationalisation and production to meet Basic Domestic Needs of Article 5 countries under the Montreal Protocol. This data excludes all production for use as an intermediate for chemical or plastic production (production for feedstock) and all used material recovered, recycled or reclaimed. (1,2)

#### **TOTAL IMPORTS**

Imports for placing on the EU market (including licensed essential and critical uses), by the EU based producer companies from countries outside the EU. Data from Importers of ozone depleting substances, who are not involved in production, is also included. This data excludes imports for feedstock use.

### **EU SALES**

Total sales of EU based producer companies within the EU, excluding sales to other EU based producer companies and sales within the EU between different branches of the same producer company, but including sales in the EU for licensed demand for essential uses. Any material used by a company for its own account within the EU is included.

## **TOTAL EXPORTS**

Exports by the EU based producer companies to countries outside the EU (including exports to Article 5 and non-Article 5 countries under the Montreal Protocol, excluding exports for feedstock use).

- (1) The "EU" is the 27 member countries of the European Economic Community: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Ireland, Italy, Luxembourg, The Netherlands, Portugal, Spain, Sweden, United Kingdom, Malta, Cyprus, Czech Republic, Estonia, Hungary, Latvia. Lithuania, Poland, Slovakia, Slovenia, Bulgaria and Romania. Following the unification of Germany, data from producer companies in the former German Democratic Republic is included from 1991-01-01. Data for Austria, Finland and Sweden is not included prior to 1995-01-01.
- (2) Data for the EU-10 Member States (Malta, Cyprus, Czech Republic, Estonia, Hungary, Latvia. Lithuania, Poland, Slovakia and Slovenia) is not included prior to 1 May 2004.
- (3) Data for the 2 new Member States (Romania, Bulgaria) is not included prior to 1 May 2008.
