- **NRRP**, Missions, Components and measures;
- **2030 Agenda**, the 169 targets;
- **NSDS**, the 5 Strategic Areas with correspondent strategic choices and strategic objectives

Considerations: NSDS within NGUE and the European Semester

- Regulation (EU) 2021/241 establishing the **Recovery and Resilience Facility**:
 - Member States are to develop their own **NRRP** while bearing in mind the Paris Agreement, the National Energy and Climate Plans, the just transition plans and the Youth Guarantee implementation plans, as well as the **UN Sustainable Development Goals**
 - The NRRP is part of the **European Semester**
 - The Commission outlined in the **Annual Sustainable Growth Strategy 2020** and the European Semester Spring and Summer Package 2020 that the European Semester should help achieve the implementation of the European Green Deal, the European Pillar of Social Rights and the **UN Sustainable Development Goals**.
- In Italy, **NSDS** transposes the 2030 Agenda principles (not only SDGs)

Considerations: Method of work

- The instrument is a method of work intended to support:
 - Allowing the focus on **territories** (with and within) (Art. 34 152/2006 – Delibera 108/2017) on **both** the **NSDS** and **NRRP**
NRRP brings extra pressure on local authorities.
 - A conducive path towards a **National PCSD Action Plan**: investigating convergences among political commitments, policy-making/governance systems, monitoring and evaluation systems within key programming cycles (*NRRP, NSDS, Cohesion policies,.....*)
 - Reflecting on the impacts of the NRRP's investment **beyond 2026** and rooting the benefits in the system in the long-term.
 - **Complexity is within reach**
